

ARTICLES OF INCORPORATION OF THE SUMMIT AT TOPS'L OWNERS ASSOCIATION, INC., A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned individual, desiring to form a corporation not for profit under the provisions of Chapter 617, Florida Statutes, hereby adopts the following articles of incorporation:

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is THE SUMMIT AT TOPS'L OWNERS ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these articles of incorporation as the "Articles", and the bylaws of the Association as the "Bylaws". ARTICLE II. TERM OF EXISTENCE

The Association shall have perpetual existence.

ARTICLE III. PURPOSE
