ARTICLES OF INCORPORATION
OF
CROSS CONNECTION MANAGEMENT CORP.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE I.

NAME

The name of the corporation is CROSS CONNECTION MANAGEMENT CORP.

ARTICLE II.

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE III.

PURPOSE

The general purposes for which the corporation is organized are: (1) to engage in the business of managing cross connection control programs for utility companies; (2) to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and (3) to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV.

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 500. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.

ARTICLE V.

REGISTERED OFFICE AND AGENT
