ARTICLES OF INCORPORATION OF ENTERPRISE FOOD & GAMES, INC.

EFFECTIVE DATE THESE ARTICLES OF INCORPORATION are hereby adopted by undersigned incorporator of this corporation for pecuniary profit under the Florida Business Corporation Act.

ARTICLE I NAME AND LOCATION OF AGENT AND OFFICES

Section 1.1 The name of the corporation shall be Name. ENTERPRISE FOOD & GAMES, INC.

Section 1.2 Principal Office and Mailing Address. corporation's principal office, if known, shall be 4723 Traylor Avenue, Sarasota, Florida 34234, and the mailing address of the corporation shall be 4723 Traylor Avenue, Sarasota, Florida 34234. The corporation may change the foregoing addresses, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Board of Directors may from time to time determine.

Section 1.3 <u>Initial Registered Agent and Office: Statement of Acceptance</u>. Section 3.1 <u>Purpose</u>. The general purpose for which the corporation is initially organized shall be to transact any and all lawful business for which a corporation may be incorporated under the laws of Florida, and to do everything necessary or convenient for the accomplishment of said purpose, and to do all other things incidental thereto or connected therewith that are not prohibited by law, and to carry out said purpose in any state, territory, district or possession of the United States or in any foreign country, to the extent not prohibited by law therein.

ARTICLE IV AUTHORIZED SHARES
