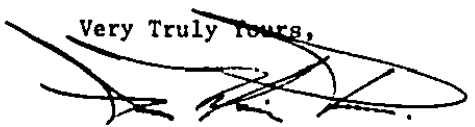

ARTICLE ONE

The name of this corporation shall be: **KASA BEAUTIFUL CONSTRUCTION CORP.**

ARTICLE TWO

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 407 of the Florida Statutes.

ARTICLE THREE

This corporation shall commence existence upon the filing of these ARTICLES of INCORPORATION by the Secretary of State, of the State of Florida, and shall have perpetual existence.
