ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is ACOF, Inc. and the principal address and principal place of business is 28469 US Hwy. 19 North, Suite 402, Clearwater, Florida 34621.

ARTICLE II - REGISTERED OFFICE AND AGENT
