The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is ***THE TREME' CORPORATION***.

ARTICLE II - DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The Corporation shall have the authority to issue One thousand (1,000) shares of common stock, in one class only, each having a par value of one dollar (\$1.00). Each of the said shares will entitle the holder thereof to one vote at any meeting of the shareholders.

ARTICLE V - REGISTERED OFFICE AND AGENT

The registered agent of the Corporation is James W. Treme'.

The registered address of the principal office of the Corporation is 406 N. Pine Meadow Drive, DeBary, FL 32713.

The Board of Directors may from time to time move the principal office to any other address in the State of Florida.


ARTICLE VIII - INDEMNIFICATION
