**ARTICLES OF INCORPORATION**

**INGERSA S.A. INCORPORATED**

Article I - Name

The name of this corporation is INGERSA S.A. INCORPORATED.

Article II - Purpose

This corporation is organized to participate in the South Florida capital markets, and for all other lawful businesses.

Article III- Capital Stock

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

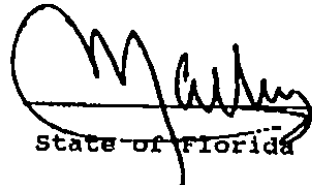
