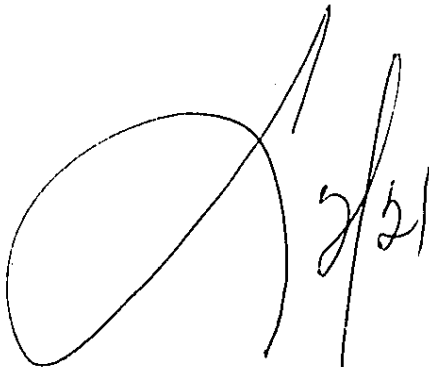

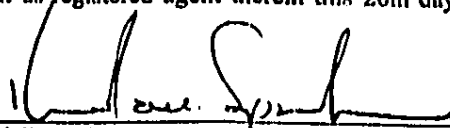
ARTICLE X -- INDEMNIFICATION
