## ARCICLES OF INCORPORATION OF

### CLAIRE KENDALL WHOLESALE DIAMONDS & JEWELRYGING

1, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by the virtue of the laws of the State of Florida under the following proposed charter:

#### ARTICLE 1 - NAME / ADDRESS

The name of the corporation shall be CLARRE KENDALL WHOLESALE DIAMONDS & JEWELRY, INC., and it's business shall be carried on in the State of Florida and such other states and countries as may be agreed upon, and it's principal place of business shall be 7042 Grand Boulevard, New Port Richey, Florida 34652, or such other place as from time to time is designated.

#### ARTICLE II - DURATION

The term and duration of the corporation shall be perpetual.

#### ARTICLE III - PURPOSE
