ARTICLES OF ENCORPORATION OF World InfoNet, Inc.

ARTICLE I - NAME

The name of the Corporation is World InfoNet, Inc. The mailing address of the Corporation is 315 East Madison Street, Suite 1000, Tampa, Florida 33602.

ARTICLE 11 - DURATION

The Corporation shall have perpetual existence commencing on the date of filing these Articles of Incorporation with the Florida Secretary of State.

ARTICLE III - PURPOSE
