The undersigned Incorporator/Subscriber of these Articles of Incorporation, is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I NAME

The name of this corporation is:

#### ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in Import, Export and Trading; and to engage in commercial and residential construction; and to engage in every and any aspect and phase of any and every lawful business, including, but not limited to, the following activities:
