ARTICLES OF INCORPORATION

OF

ANITA BUCKMAN, PA

I, the undersigned, being of full age, and Jurin and citizen of the United States, hereby file these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation shall be Anita Buckman, PA.

ARTICLE II

This corporation is designed to engage in real estate sales.

ARTICLE III

The total authorized capital stock of this corporation shall be 100 shares of common stock of par value of \$1.00 per share. Said stock shall be paid for in cash or property, labor or services at a just valuation to be fixed by the incorporator in the manner provided for by statutes, and the stock shall be issued in accordance with such valuation. The value of the common stock thereof shall be fixed by the incorporator in the manner provided for by statutes, and the stock shall be issued in

accordance with such valuation. The capital stock shall be Section 1244 stock.

#### ARTICLE IV

The amount of capital with which this corporation shall begin business shall be not less than One Hundred (\$100.00) Dollars.

#### ARTICLE V

The corporation shall have perpetual existence unless sooner dissolved according to law.

#### ARTICLE VI

The principal place of business and general office of this corporation shall be at 3495 Travis Place, Florida 32780, but it may maintain offices and transact business at such other places, either within or without the State of Florida, as the Board of Directors may from time to time provide by resolution. The registered agent for the corporation shall be Anita Buckman, whose business office is located at 3495 Travis Place, Titusville, Florida, which office is hereby designated as the registered office of the corporation.

#### ARTICLE VII

The business of the corporation shall be conducted by Anita Buckman, the only stockholder of this corporation.

The highest amount of indebtedness to which this corporation may at any time subject itself shall be unlimited.
