The principal place of business of the corporation is 964 Hwy 441 SE Okeechobee, FL 34974.

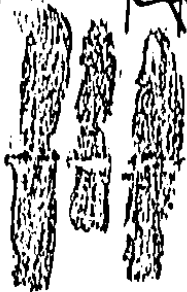
