The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be The Chapel in Orange City, Inc., and the proposed place of business shall be 973 Feather Dr., Deltona, FL 32725.

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.

ARTICLE III

A. The purposes for which The Chapel in Orange City, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE IV

The qualifications for members are that they must be born again Christians, and to obey the Lord in believer's baptism.

#### ARTICLE V

The number constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve initially are:

#### ARTICLE VI

This corporation is organized under a non-stock basis.

#### ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in §501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.
