ARTICLE I

The name of the corporation is Langer & Associates of Central Florida, Inc. [hereinafter called the "Corporation"].

ARTICLE II

The purpose for which the Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the laws of the United States and the State of Florida.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

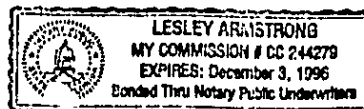
