MOCCIA & ALLARD, M.D., P.A.

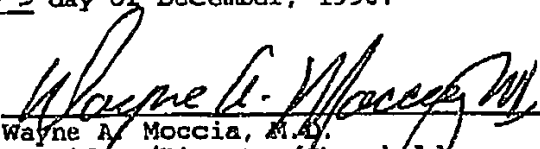
The following amendment was adopted by the Board of Directors of this corporation on December 17, 1996. The Shareholders unanimously approved this amendment on December 17, 1996.

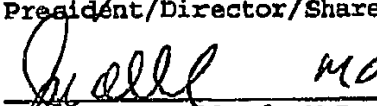
ARTICLE I
