

**ARTICLES OF DISSOLUTION AND

1. NAME OF CORPORATION: The name of the corporation being dissolved is JAMES R. KOSYDAR, D.D.S., P.A. (the "Corporation").
2. DATE OF INCORPORATION: The original Articles of Incorporation of the Corporation were filed on 1/5/93.
