## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

## COMMUNITY HOUSING PARTNERSHIP OF COLLIER COUNTY, INC.

We the undersigned, being the President and Secretary of Community Housing Partnership of Collier County, Inc., a Florida non-profit corporation, hereby certify that the following amendments to the Articles of Incorporation were duly adopted by the Board of Directors at a meeting duly held by them on the 28th day of March, 1997. These Articles of Amendment do not contain any amendments requiring member approval.

Article VI is amended to read:

"The Corporation shall have seven (7) Directors. The number of Directors may increase or decrease from time to time by By-Laws adopted by the Board of Directors, but shall never be less than three (3)."

The second "Article VII" is renumbered to read "Article VIII."

Article XII is amended to read:
