ARTICLES OF INCORPORATION

OF

RDS FINANCIAL SERVICES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be: RDS FINANCIAL SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - DURATION

The duration of the Corporation is perpetual.

ARTICLE IV - PURPOSE
