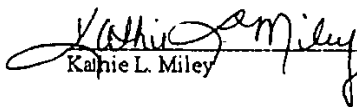
**Article 6: Purpose**

The purpose of the corporation is any lawful business purpose authorized within the state.

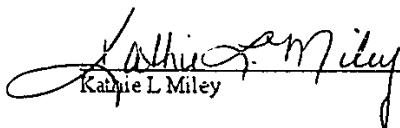
