

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

1. The name of the corporation is SEIZIN PROPERTY MANAGEMENT, INC., whose mailing address is 402 West Violet Street, Tampa, Florida 33603.
2. The period of its duration is perpetual.
