As evidenced by Federal Registration Number 1,583,069, the mark "Second Chance" is used for "chemical dependency treatment services on both an in-patient and out-patient basis." This is a different business than the business for which we are requesting the servicemark "2nd Chance." Thus, this registered servicemark should not adversely affect our ability to obtain a State of Florida registration for the servicemark "2nd Chance."

The Federal Registration bearing number 1,633,405 is for "banking services, namely issuing certificates of deposit," which is different from our client's business of selling used motor vehicles and providing related services. Further, this registration is a Class 36 registration and our client's application is for registration in Class 42. 




