Pursuant to our conversation of March 18, 1995 during which you stated that we could register the servicemark "2nd Chance" if the Federal Registrations that are in conflict with our application to register the servicemark were for different trades or businesses, we have obtained copies of the Federal Registration for each of the registrations that were cited as reasons for the denial of our application for registration of the servicemark "2nd Chance." As you will discover, the Federal Registrations are for businesses that are significantly different from our client's business of used motor vehicle sales and related services. Copies of each of the Federal Registrations are enclosed for your review.

As evidenced by Federal Registration Number 1,583,069, the mark "Second Chance" is used for "chemical dependency treatment services on both an in-patient and out-patient basis." This is a different business than the business for which we are requesting the servicemark "2nd Chance." Thus, this registered servicemark should not adversely affect our ability to obtain a State of Florida registration for the servicemark "2nd Chance."


The Federal Registration bearing number 1,633,405 is for "banking services, namely issuing certificates of deposit," which is different from our client's business of selling used motor vehicles and providing related services. Further, this registration is a Class 36 registration and our client's application is for registration in Class 42. Thus, the Federal Registration should not cause our application for servicemark registration to be denied.

Please review our submissions and when the servicemark is registered, please advise us of our registration numbers. If you need further material or information, please advise us of what is needed to register these servicemarks.


