The name of this corporation is Classic Restaurants of North Florida, Inc.

ARTICLE XI

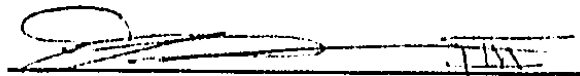

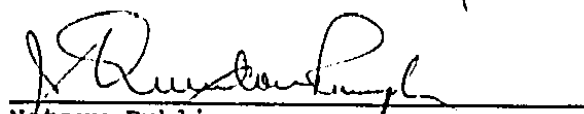
