ARTICLES OF INCORPORATION
OF

The undersigned Incorporator hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME AND BUSINESS ADDRESS

The name of the corporation shall be:

Steven D. Weissman, D.M.D., P.A.

The address of the principal office of this corporation shall be 1031 Kane Concourse, Bay Harbor Islands, Florida 33154, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in every aspect of the business of rendering the same professional services to the public that a dentist, duly licensed under the laws of the State of Florida, is authorized to render.

ARTICLE III. CAPITAL STOCK




