I, the undersigned being of legal age and a natural person, do hereby subscribed to, acknowledged, and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be:

DOBA CORPORATION

ARTICLE II

The purpose of this Corporation is to transact any or all lawful business for which corporations may be incorporated under chapter 607 of the Florida Statutes.

ARTICLE III

This Corporation is authorized to issue 50(fifty) shares of common stock with a par value of \$ 2.00 a share. All of said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash; at a just valuation to be fixed by the Board of Directors of this Corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which already holds, every stockholder of this Corporation shall have the pre-emptive right to purchase his pro-share thereof at a price at which it is offered to others, whether or not in excess of part.

Fractional shares need not be issued on account of these provisions.
