**ARTICLE I: NAME**

The name of this corporation is **COASTAL HOME SERVICES, INC.**

**ARTICLE II: DURATION**

This corporation shall have perpetual existence.

**ARTICLE III: PURPOSE**

This corporation is organized to transact any lawful business

purchasing or otherwise acquiring, and to own, mortgage, pledge,


**ARTICLE IX: INDEMNIFICATION**






