ARTICLES OF INCORPORATION

OF

JEFFREY H. ROLLAND & ASSOCIATES, INC.

ARTICLE I

The name of this corporation is: Jeffrey H. Rolland & Associates, Inc. The principal office of the corporation is located at 1650 Prudential Drive, Suite 202, Jacksonville, Florida 32207.

ARTICLE II

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

ARTICLE III

The total number of authorized shares of the capital stock of this corporation is ten thousand (10,000) shares, consisting of one class only, designated as "common stock," and having a par value of ten cents (\$0.10) each. Each issued and outstanding share shall be entitled to one vote. The shareholders may, by Bylaw provision unanimously approved or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE IV

This corporation shall have perpetual existence. The existence of this corporation shall begin as of October 9, 1996.

ARTICLE V

The number of directors that the corporation shall have shall be not less than one (1) but may be such greater number as may be elected by the shareholders from time to time in accordance with the Bylaws of the corporation. Initially, there shall be one (1) director.
