ARTICLE II - DURATION

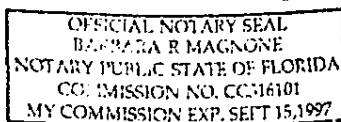

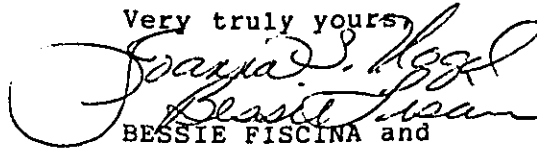
