The undersigned subscriber(s) to these Articles of Incorporation each natural person competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: THERAPEUTIC BODYWORKS, INC.

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on is: provide Therapeutic or Swedish Massages, Craniosacral Therapy, Headache, Neck and Facial Pain Relief, Arthritis Pain Management, Reflexology, relieve Stress, Tension, Fatigue, and all its fields of specializations as are in engaged by law.

And, in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.

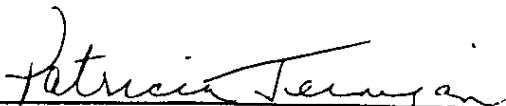

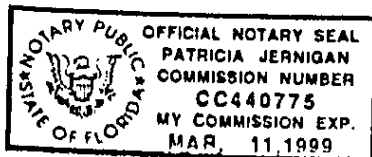
