The undersigned subscribers to shear Articles of Incorporation, and a contract, hereby aurociate themselves together to form a corporation under the Laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter mentioned, and they hereby make, subscribe and acknowledge and file with the Secretary of State of the State of Florida this Certificate of Incorporation; and to that and they do, by this Certificate, set forth the following Articles of Incorporation:

ARTICLE 1

The name of this Comporation shall be: METROPOLITAN INVESTMENTS COMP.

ARTICLE II

The general nature of the business and the objects and purposes to be performed and carried on are to do any and all things allowed and permitted to be done by corporations under the Statutes of the State of Florida, and to do any and all of the things bereisefter mentioned, as fully and to the summ extent as natural persons might or could do, to wit:

s) To carry on a general investment and management consultant and advisory business relating to the investments and the operation of business, plants, properties, and real and personal property of every kind, in the Unites States and foreign countries, subject to the applicable laws thereof. executive and operating personnel for the purpose of consulting with and advising others in all mattern relating to investments and the management and operation of business and other properties of every kind. To furnish business invostment and management plund and programs, to formulate policies, and generally to advise and assist others, under contract or otherwise, in the management of their businesses, plants, properties and investments. To buy and sell projects and developments on its own behalf and on behalf of others is connection with the operation.

To subscribe for, purchase of otherwise acquire, underwrite, obtain an interest in, own, hold, pledge, hypothecate, mortgage, grant security interests

in, assign, deposit, create trusts with respect to, sall, exchange, or otherwise dispose of and generally soal in and with securities of every kind and description of any government, state, territory, district, municipality, or other political or governmental division or subdivision, body politic, corporation, association, partnership, firm, trustee, syndicate, individual, combination, organization, or entity whatsoever located in or organized under the laws of any part of the world, including (without limiting the generality of the foregoing) stocks, shares, woting trust certificates, bonds, mortgages, debantures, notes, land trust cortificates, warrants, rights, scrip, commercial paper, choses in action, evidences of indebtuduess, certificates of interest of other obligations or other securities of any nature howspever evidenced; Too acquire or become interested in any such necurities by original subscription, underwriting, participation in syndicates, or otherwise irrespective of whether or not such ascurities are fully paid or subject to further payments or assessments; to exercise any and all rights, powers, and privileges of individual sweership or interest in respect of any such securities, including the right to vote thereon and otherwise act with respect thereto, and promote, manage, participate in, and act as agent for any underwriting, purchase, or selling syndicate or group and otherwise to take part in and assist, in any legal manner, by guaranty or otherwise, the purchase, sale; or distribution of any such securities; to promote, finance, aid, and assist, financially or otherwise, any body policic, corporation, association, partnership, firm, trustee, syndicate, individual, combination, organization, or other entity, located in or organized under the laws of any part of the world;

to purchase, lease, or otherwise acquire, take over, hold, sell, liquidate, for otherwise dispose of the business and properties, of every kind, of corporations, especiations, partnerships, firms, trustees, syndicates, individuals, combinations, organizations, and other entitles located in or organized under the laws of the world; to continue, alter, extend, and develop their business, assume their limbilities, guarantes or become surety for the performance of their obligations, reorganize their capital, and participate in any way in their affairs, and to take over as a going concern and to continue in its own name my business so acquired; and to sot as financial, commercial, special, or general agent or representative of bodies politic, corporations, associations, partnerships, firms, trustees, syndicates, individuals, combinatious, organizations, and other antities located in or organized under the laws of any part of the world.

To set as public relations and research counsellors and promotion, merchandising, and industrial counsellors and business consultants, and in connection therewith to render management, negetiation, research, technical, and advisory services to persons, firms, corporations, and others in connection with their relations with employees, associates, stockholders, government officials and agencies, and the general public and any person or special group.

To serve in an advisory, managerial, and consultative capacity to corporations, associations, partnerships, individuals, and others, to establish and maintain

bureaus, departments, and laboratories for industrial, financial, statistic, inventory, and other renearch work, and to engage generally in the business of providing, promoting, and establishing systems, methods, and controls for industrial and managerial efficiency and operations.

To investigate systems, methods, and controls of manufacturing, plant operations, packing, storing, shipping, marketing, inventories, accounting, and other operations integral to any and all types of businesses and to make recommendation revise, adapt, modernize, and establish economies to effect industrial and managerial efficiency and in connection therewith to take over the entire operation and business of any type of industry or other forms of endeavor and to do all such things and to perform all such services as may be necessary to carry out the foregoing purposes.

To devise, develop, creave, insugurate, and contract for the establishment, installation, and sale and rental of systems, methods, and controls for efficient operation and management of industrial manufacturing, mercantile, commercial, or other business concerns, firms, partnerships, associations, and corporations and to provide, make available, and furnish maintenance and supervision and to train and instruct individuals in the operation, installarion, and maintenance of such systems, methods, and controls.

So far as sauthorized by the law under which this cortificate is drawn: to examine and inspect the books and accounts of others, to devise and install financial, checking, correspondence, filling, and other office and business systems; to take inventories; to make appraisals; to compile statistics as an

aid to the officers of the corporations and other perf as in the making of reports and statements; to do all such things and perform or supply all auch services as are commonly done, performed, or supplied by husiness management expersa; to warrant the accuracy of the work done or services performed by it, but not to engage in the practice of accounting.

To engage in the business of buying, selling, and other wise dealing in or with, in any manner whetsoever, as broker, agent, or principal, and on commission or otherwise, options and all other manner of contracts repassering the purchase, sale, or other disposition of shares, bonds, notes, mortgages, debentures, and other securities or any interest therein.

The foregoing clauses shall be contrued as end shall be powers as well as purposes, and the matters expressed in each clause shall, unless otherwise herein expressly provided, be in no wise limited by reference to or in reference from the terms of any other clause but shall be regarded as independent powers and purposes; and the enumeration of specific powers and purposes shall not be construed to limit or restrict in any manner the meaning of general terms or the general powers of this Corporation, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature.
