

1. The name of the corporation is Crystalites, Inc.
2. The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.
3. The corporation shall have the authority to issue 10,000 shares of common stock, in one class only, each with a par value of \$1.00.


