The undersigned incorporator, WILLIAM J. MORSE, JR., hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is 4821 SIERRA, Inc. whose corporate principal office is 2199 S.R. 3, St. Augustine, FL 32084.

ARTICLE II NATURE OF BUSINESS


