

**STATEMENT OF RESIGNATION**

Natchez Trace Homeowners' Association, Inc. is listed in the records of the Florida Department of State as having been dissolved in August 1996 for failure to file required annual reports. Even though new officers were purportedly elected in December 1995, they apparently failed to file the required annual report which was due May 1, 1996 and, as a result, the Association has been dissolved by administrative action of the Department of State. The last annual report filed with Department of State prior to the Association's dissolution lists me as its President, Director and Registered Agent.

Pursuant to Section 617.0502(2), Florida Statutes (1995), I hereby resign as Registered Agent of Natchez Trace Homeowners' Association, Inc., effective as of the thirty-first (31st) day after the Department of State's receipt and filing of this Statement. Under the law, my resignation as Registered Agent also has the effect of terminating the registered office of the Association as heretofore set forth in the Department of State's records.

A copy of this Statement of Resignation has been mailed to the Board of Directors and to the Chairman of the Board of Directors of Natchez Trace Homeowners' Association, Inc. at its principal office address as shown in its most recently-filed annual report. A copy of this Statement of Resignation is also being mailed by certified mail, return receipt requested, to each and every person shown in the tax rolls of the Osceola County property Appraiser's office as the owner (or co-owner) of each of the 48 lots which comprise the Natchez Trace Subdivision, each of whom are automatically, by virtue of their ownership of such lot(s), members and owners of the Natchez Trace Homeowners' Association, Inc.
