ARTICLES OF ORGANIZATION OF BEN'S HITCHING POST CAMPGROUND, L.C.

The undersigned certify that we have associated ourselves together under and pursuant to Florida Statutes § 608 entitled "The Florida Limited Liability Company Act" for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE 1. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **BEN'S HITCHING POST CAMPGROUND, L.C.,** and its principal office shall be located at 2440 N.E. 115th Avenue, Silver Springs, Florida, 34488, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

- 2.3 To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this limited liability company is authorized to carry on, pursuant to the provisions of these Articles; and to hold, utilize, and in any manner dispose of the rights and property so acquired.
- 2.4 To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or growing out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida. The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers. ARTICLE 7. PROFITS AND LOSSES

- 7.1 Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of conducting the business of the limited liability company. Each member shall be entitled to a distributive share of the profits in proportion to their membership interest. The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the month and day of the commencement of business of the limited liability company.
