AMENDMENT TO ARTICLES OF INCORPORATION

Museum of Art Foundation, Inc., a Florida not-for-profit corporation, that the Articles of Incorporation of the aforesaid corporation are hereby amended as follows:

ARTICLE IV - DIRECTORS & OFFICERS

"Section 1. The affairs of this corporation shall be managed by the Board of Directors, who shall constitute the only members of this corporation and who shall have full authority and all of the powers granted to the directors of corporations not for profit under the laws of Florida. There shall be sixteen (16) Directors appointed by the Board of Trustees of The John and Mable Ringling Museum of Art. Of the sixteen (16) Directors, not less than eleven (11) shall be members of the Board of Trustees of The John and Mable Ringling Museum of Art. The Directors shall serve at the pleasure of the Board of Trustees of The John and Mable Ringling Museum of Art and may be removed at any time with or without cause."

2. Article VI is hereby amended to provide as follows:

ARTICLE VI - BYLAWS

"The Bylaws of this corporation shall be made, altered or rescinded by the Board of Directors, subject to the prior written approval by the Board of Trustees of The John and Mable Ringling Museum of Art. The Bylaws shall operate to carry out the purposes of this corporation as expressed herein and to facilitate the operational procedures thereof. To the extent permitted by law, the Corporation adopts and shall comply with the Bylaws adopted by the Board of Trustees of The John and Mable Ringling Museum of Art as may be amended from time to time; provided, however, in order to obtain a quorum, for the Board of Directors of this Corporation to properly convene a meeting of the Board of Directors and to take actions on behalf of this Corporation, shall require, in addition to a majority of Directors of the Corporation, a quorum of at least six (6) Trustees of the Board of Trustees of The John and Mable Ringling Museum of Art who are concurrently serving as Directors of this Corporation. An affirmative vote of at least eleven (11) members of the Board of Directors and written approval by the Board of Trustees of The John and Mable Ringling Museum of Art shall be required to effect any alteration, change or amendment to the Bylaws."

3. Article VII is hereby amended to provide as follows:

ARTICLE VII - AMENDMENT

"These Articles of Incorporation may be altered or amended only by the Board of Directors and only with an affirmative vote of at least eleven (11) members of the Board of Directors and approval by the Board of Trustees of the John and Mable Ringling Museum of Art."

IT IS HEREBY CERTIFIED that there are no members of this corporation other than the Board of Directors, and the number of votes cast for the foregoing Amendment was sufficient for approval.

IT IS HEREBY CERTIFIED that the foregoing is a true and correct copy of the Resolution duly adopted by The John and Mable Ringling Museum of Art, Foundation, Inc., at a regular and duly noticed meeting of the Board of Directors of said corporation on <u>June 17</u>, 1997.
