The undersigned incorporator hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME.

The name of the corporation shall be: Bernd Wollschlaeger, MD, P.A.

ARTICLE II. ADDRESSES.

The address of the principal office of this corporation shall be 7933 West Drive, Unit #506, North Bay Village, FL 33141 and the mailing address of the corporation shall be the same.

ARTICLE III. NATURE OF BUSINESS.

This corporation may engage in every aspect of the business of rendering medical services to the public that a physician licensed under the laws of the State of Florida is authorized to engage in.
