The undersigned, acting as incorporator of NOVA MARKETING & DISTRIBUTION GROUP, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation is NOVA MARKETING & DISTRIBUTION GROUP, INC.

#### ARTICLE II. ADDRESS
