OF

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following articles of incorporation:

ARTICLE I

The name of the corporation shall be:

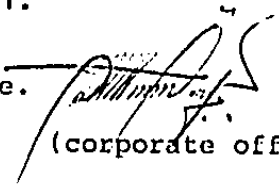

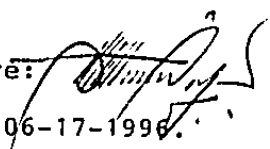
