I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be GRAND PALMS ENTERPRISE, INC., and the initial address of this corporation shall be 110 Grand Palms Drive, Pembroke Pines, FL 33027.
