# ARTICLES OF INCORPORATION

GREAT SOUTHERN CONSTRUCTIONS SOUND FL

The undersigned subscribers, each a natural person competent to contract, and where required, duly licensed to render the services mentioned in Article II - Purpose, hereby organize and incorporate a business for profit under the laws of the State of Florida.

#### ARTICLE I - Name

The name of the corporation shall be: GREAT SOUTHERN CONSTRUCTION INC.

#### ARTICLE II - Purpose

The corporation is formed to engage in Residential & Commercial construction

and all activities and operations directly or indirectly related thereto, or in any activity or business permitted under the laws of the United States or this State.

#### ARTICLE III - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is
