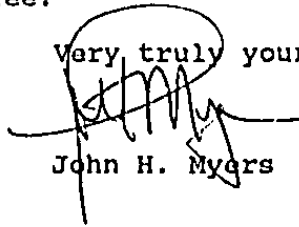

ARTICLES OF INCORPORATION

OF

MR. INSPECTOR, INC.

BY THESE ARTICLES OF INCORPORATION, the incorporators form a corporation for profit under Florida law.

NAME

The name of this corporation is MR. INSPECTOR, INC.

TERM

This corporation shall exist perpetually.

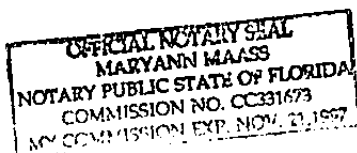
