ARTICLES OF INCORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation is DIAMOND PAVING AND SEALCOATING COMPANY, INC. The address of the principal office of this corporation shall be 2533 S.E. 10th Street, Pompano Beach, Florida 33062.

## ARTICLE II. TERM

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is when the Articles are received in the office of the Secretary of State.

# ARTICLE III. PURPOSE

The general purposes for which the corporation is organized are to transact any and all lawful business under the laws of the State of Florida.

# ARTICLE IV. CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is Five Thousand (5,000) shares. Such shares

shall be of a single class and shall have a par value of One (\$1.00) Dollar per share.

### ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI. ADDRESS

The street address of the initial registered office of the corporation shall be 2533 S.E. 10th Street, Pompano Beach, Florida 33062, and the name of the initial registered agent of the corporation at that address is Joyce DiTucci.

#### ARTICLE VII. DIRECTORS

The number of Directors constituting the initial Board of Directors of the corporation is 1 (one). The number of Directors may be either increased or decreased from time to time by the Bylaws but shall never be more than three nor less than one.
