ARTICHES OF INCORPORATION OF NICK COMMUNICATIONS, INC.

ARTICLE I

The name of this corporation shall be as follows:
NICK COMMUNICATIONS, INC., and the initial principal office of
this Corporation shall be: 3300 NE 192 STREET, SUITE 101,
AVENTURA, FLORIDA 33180.

ARTICLE_II

The commencement of existence of the corporation shall be the date of filing.

ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz:
