ARTICLES OF INCORPORATION  
OF  
ACTION PRODUCTIONS, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is Action Productions, Inc..

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business and engaging in any activities or business for which corporations may be incorporated under Chapter 607, Florida Statutes as now exists or may hereafter be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one-thousand (1,000) shares of common stock at one dollar (\$1.00) par value per share.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The initial street address of the principal office of the corporation is 106 Tortuga Court, Davenport, Florida 33837. The name of the initial registered agent of this corporation at that address is Larry Lee.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation initially shall have one (1) director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by amendment of the bylaws for the corporation; however, there shall

never be less than one (1) director.


#### ARTICLE IX - INDEMNIFICATION

#### ARTICLE X - AMENDMENT



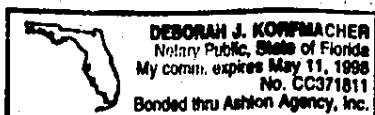
