**ARTICLES OF INCORPORATION
OF**

KRISHNA ASSOCIATES, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation is : KRISHNA ASSOCIATES, INC.

ARTICLE II - DURATION

This Corporation is shall commence its existence on date of filing with the Secretary of State and shall exist perpetually hereafter unless sooner dissolved according to law.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida and of the United States.

Every Shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, Class or Series as that which he already holds, shall have right to purchase his pro-rata share (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.
