The undersigned person, having the age of eighteen (18) years or more, has associated himself for the purpose of forming a corporation under the laws of the State of Florida and does hereby adopt the following Certificate and Articles of Incorporation.

- The name of this corporation is Webtech Advertising, 1. Inc.
- 2. Purpose and Powers. This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time, and specifically but not limited thereof, the purpose of: Developing Internet Advertising.

This corporation shall have the broad general powers set forth by regulation and statute in this state.

- 3. Duration. The duration of this corporation shall be for inperpetuity.

The number of class "A" shares of common voting stock shall be one-thousand (1,000) shares with a par value of one dollar (\$1.00) per share.
