#### **EXHIBIT "A"**

## PROPOSED AMENDMENT TO THE ARTICLES OF INCORPORATION FOR LAKE CHARLESTON MAINTENANCE ASSOCIATION, INC.

1. Article V, Section 1 of the Articles of Incorporation shall be amended to read as follows:

Section 1. Management by Directors. The property, business and affairs of the Association shall be managed by the Board of Directors, which shall consist of not less than three (3) persons and not more than five (5) persons five (5) and not more than nine (9) persons. The number of Board members for the following year (from 5 to 9) to be established by the District Voting Members at the December Voting Meeting of each year. A majority of the directors in office shall constitute a quorum for the transaction of business. The by-laws shall provide for meeting of directors, including an annual meeting.
