FIRST: The name of the limited liability company is HARBOR AIR, L.C.

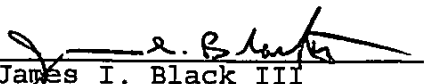
SIXTH: One (1) or more additional members may be admitted to the limited liability company with the consent of all of the members.
