In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is "LENAMON FINANCIAL INC.".

ARTICLE II

The existence of the corporation shall begin on February Twenty-Eighth (28th), Nineteen-Hundred-Ninety-Seven (1997).

ARTICLE III

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is One-Thousand (1,000), all of which shall be Class "A" Common Shares.
